We believe the Bible to be the inspired, infallible and authoritative Word of God. We believe the Bible is without error in the original manuscripts, written under the inspiration of the Holy Spirit, and that it has supreme authority in all matters of faith and conduct. We believe the Bible is the revelation of God's plan of salvation for mankind. We believe that this Statement of Faith does not exhaust the extent of our beliefs. For the purposes of First Love Christian Academy, our Board of Directors is the final interpretive authority on the Biblical meaning and application.

(II Timothy 3:15; II Peter 1:20, 21)

We believe that there is one living and true God, eternally existing in three persons: Father, Son and Holy Spirit.

(Genesis 1:1; Deuteronomy 6:4, Matthew 28:19; John 10:30, II Corinthians 13:14, Romans 3:23)

We believe that God created the universe and that it was perfect; that man was created in the image of God, but fell into sin; that all men are sinners by nature and under God's condemnation. We believe that when God creates each person to be biologically identified at birth as male or female, that specific gender is the gender God intended for them to identify.

We believe that Jesus Christ is fully human, and fully God. We believe that Jesus Christ is God's only begotten Son, conceived of the Holy Spirit. We believe in His virgin birth, sinless life, miracles and teachings. We believe in His substitutionary atoning death, bodily resurrection, ascension into Heaven, perpetual intercession for His people, and personal and visible return to earth. We believe that Jesus sits at the right hand of the Father and intercedes on our behalf.

We believe that all human life is sacred and created by God in His image, including pre-born babies, the elderly, the physically and/or mentally challenged, and every other stage or condition beginning at conception through natural death (**Psalm 139**)

We believe every believer has a scriptural mandate to share his life of faith in Christ. We believe the only Christ many will ever see is the Christ they see in us, thereby making our personal lives the most powerful influence for an effective Christian witness.

Note:

- An application fee of \$100 must be included with the initial application.
- Students may be placed on a Visitor Status before all paperwork is completed. In some cases, a Visitor Status may be warranted for students who start after the school year begins or if there is a history causing concern. After the two weeks, students then will be placed on Probationary Status.
- All new Students will be on a probationary status during their first quarter. Probationary Status is not full enrollment which means a student is not guaranteed full enrollment and can be dismissed.
- Be sure to distribute Spiritual Leader, Teacher, and Christian Reference Forms and ask the reference person to mail the forms back within a week from the time you turn in your enrollment application. If the initial application is approved, the student will receive the following documents: Family Registration Form (for language survey, pick-up and contact information, and health, insurance and medical information), Financial Information & Contract.
- Please keep in mind that students are expected to attend a Church worship service supporting FLCA's Statement of Faith on a weekly basis in school and also out of school.
